### **Chicken License fee:** (Applicable to residential lots equal to or greater than $\frac{3}{4}$ acre)

1-5 Chickens:	No charge
6-25 Chickens:	\$5.00
Late fees:	double fees

**Property Taxes:** \$1.00/page, for duplicate copies of bills, by mail

**Photocopying fee:** \$0.25/page

**Late Payments:** Outstanding balances are subject to 18% interest, billed as 1.5% monthly

More than 100 sq f	\$ 200.00+ \$ 100.00 Renewal fee every 2 years
 Violation of Sign Ordinance:	 Four times the permit fee

Note: Failure to take out building, plumbing, HVAC or electrical permit will result in double fees being charged for the first offense and quadrupled fees for multiple violations.
